RE: 2009 HCPCS Code Set From: Paul Kesselman, DPM

CMS in its attempts to keep us on our toes, has issued its annual HCPCS Code Set Update. The 2009 update will have its most significant effect particularly on podiatrists who provide advanced tissue engineered products. Effective January 1, 2009. All the current "J" codes for tissue-engineered products will be replaced by a new set of "Q" codes.

Unfortunately this news, released 11/03/08, has come far too late to appear in the annual update on tissue-engineered products published in the Nov/December issue of *Podiatry Management*.

The January issue will contain a full cross-walked chart for all the tissue engineered products contained in the Nov/Dec article on tissue engineered products. An early rendition of the chart appears below:
