## Is Your **Office Safe?**



Dealing with internal perils requires setting up a system of checks and balances, which ensures that no single employee is given the total responsibility for collecting, recording, and depositing cash or checks, and that when possible, insurance checks should be sent to your bank via direct deposit.

Unfortunately, there is no way to be totally safe, but taking a proactive stance can reduce the chance of your becoming a victim.
