Steve McClain, MD—Hall of Fame inductee.



ll boys want toyssome want trains and some want cars. Dr. McClain was seven years old when he got his first microscope. Dr. McClain has impacted the lives of many people-from his employees to thousands of patients. He has spent his life looking through the microscope lens to diagnose and treat patients. The main theme is his compassion and commitment to taking care of others. Dr. Mc-Clain's passion has led us to a journey through the lens of the microscope from one man's dream to the reality of McClain Laboratories.

Let's turn the microscope lens around and take a look at Dr. McClain. Dr. McClain was born and raised in St. Louis, Missouri. He began his journey at Missouri State Universi- Dr. McClain ty when he achieved his bach-

elor's degree in Biology in 1976, Summa cum Laude. Dr. McClain continued his journey to medical school at the University of Missouri. He received his medical degree in May of 1982.

Dr. McClain did his pathology residency in Clinical and Anatomic Pathology at the Medical Center in Burlington, Vermont from 1982-1986. Dr. McClain spent time on the West Coast and was a staff pathologist in Bellingham, Washington in 1986-1992. Dr. McClain remained on the west coast until he went east to New York. He often refers to these years as the "lost years" where he



worked and paid off his medical school debts.

He came to New York University in 1992 to specialize in dermatopathology and did a fellowship with Dr. Bernie Ackerman, one of the world's leading experts in dermatopathology.

I met Dr. McClain in 1994 when he came on staff at Stony Brook University Hospital. I was the supervisor of the pathology laboratory. It was a very intense job, as we had 10 pathologists and 10 residents all specializing in different areas of Pathology. He was the Director of the Dermapathology Section in the Department of Dermatology at SUNY

Stony Brook from April 1994-November 1999.

Dr. McClain is a perfectionist and this is one of his best and worst traits. I didn't know it at the time, but his attention to detail would be the one thing that would separate him from the average pathologist. He would ask us to cut slides over and over again—a task that is quite maddening, actually. I remember vividly him coming into the Stony Brook lab and thinking-here he is-this is going to be another recut! This is the cornerstone of McClain Labstrying to achieve perfection on every slide so he can properly diagnose the patient.

My first thought was, oh boy, who is this country doctor? We hit it off like peas and carrots. Dr. McClain was demanding, but encouraging. He worked with me on my first presentation ever that I presented at the National So-

ciety for Histotechnology. He said if I did the poster, I could attend the conference with his financial support. It was a poster on Lyme disease. Dr. McClain and I worked together on images of ticks and spirochetes-long before we had cell phones and the Internet. I presented it at the National Society for Histotechnology convention and won the poster competition!

Dr. McClain continued his journey as he left Stony Brook to become the Director of Dermatopathology at Montefiore Medical Center in the Bronx from 1999-2004. We remained in contact professionally and at this Continued on page 66

point, I was working in the Quality Management Department at Stony Brook University Hospital.

In 2003, Dr. McClain told me he was thinking about opening his own laboratory. I said good luck and wished him well. He was persistent and wanted me to come on this journey with him. I thought he is a madman and how can I leave my job at a top rated tertiary academic medical center to follow this man to an empty building? At this point, I was also a mom to a two-year old daughter so I was not ready to jump onto a new ship.

I wanted to be part of his dream, but I was afraid. My mother always said to climb out on the tree branch to grab a low hanging fruit. If the branch breaks, you can always climb up another tree and try again. You need to get up, dust yourself off, and find a new tree. Sometimes the branch does not break and you can get your fruit. But reaching outside of our comfort zone is hard to do. Fear holds us back. Faith comes before fear in the dictionary and that is what McClain Labs was built on. I decided to give it a try and met with Dr. McClain. What is the worst that could happen? I thought, if the lab fails, I would go back to the hospital job.

Dr. McClain is an academic pathologist. His true passion is to teach. Most pathologists are happy to spend their time behind the microscope lens and not interact. Not Dr. McClainhis true joy comes from teaching students, residents and doctors about pathology. His first speaking engagement for podiatry was a request from one of our first clients-Dr. Elliot Udell. He asked Dr. McClain to lecture at the former Cherry Blossom meeting in 2011. I was overwhelmed with gratitude and Dr. McClain has not looked back since! He continues to be a national and local speaker for the podiatry profession.

Dr. McClain has authored over 100 publications. He donates his time to helping others and giving back to the profession; and his fierce dedication to the podiatry profession and his commitment to excellence have been the driving forces of McClain Laboratories. We will celebrate our 20th year in 2024 and I am so proud! From his humble beginnings as a "country doctor", as he calls himself, to being a leader in the podiatry profession—it truly a dream come true. He teaches us all to put others before ourselves.
