

Paul Kesselman, DPM **PM Lifetime Achievement Award Recipient**

He's podiatry's foremost authority on DME.

r. Paul Kesselman, a long-time resident of Oceanside, Long Island, NY, was raised in Brooklyn, NY. His undergraduate degree was at SUNY Albany, NY which allowed him to meet Rachel, his beloved wife, during his senior year. He pursued his podiatric medical career at the Illinois College of Podiatric Medicine ICPM) in Chicago and then got married during his second year. Rachel was busy as a computer programmer analyst as he went on to complete his podiatric medical school training. His initial career took him to an internship in New York City, where he met a lifelong friend Rob Sny-

He loved private practice, running two office locations and being attending surgeon at two hospitals with residency programs. His work with the late Dr. Kesselman Dr. Harry Goldsmith enabled him

to pursue his other love, educating the profession. He related that he met Harry Goldsmith at a meeting in Connecticut about 25 years ago. When he received a call from Harry a few months later, he thought he was being investigated and audited. Instead, Harry asked if Paul had any public speaking experience. Another connection that he developed subsequently was his being introduced by Ken Malkin to Barry Block at an NYSPMA meeting. Barry and his wife Hermine treat Paul like another son, they have mentored and fostered his growth as a writer. Their mutual respect and affection for one another is easy to appreciate. These two individuals--Harry and Barry--have been critical in his overall development as the DME expert Paul is today!
